The Sleeping Judge

Many years ago in England there was a judge by the name of Doddridge who gained the nickname "the sleeping judge." As he would listen to a case before him in court, he would often close his eyes, slump down in his chair, rest his chin on his chest, and give every appearance of being asleep. Many people appeared in his court in hopes that the law would give them justice. They would hope that the righteousness of their position would be evident, but their hopes would begin to fade as they looked at this sleeping judge. On the other hand, some would appear in court who were guilty of wrongdoing and would hope that justice would not prevail. As they would observe this sleeping judge, they began to hope that they would escape judgment. Judge Doddridge, though, was not asleep. He was concentrating intently on the evidence being presented before him, analyzing it with his great legal mind, and determining what was just. His legal pronouncements were always sound, for the sleeping judge was not sleeping.

Certain false teachers, with whom the apostle Peter was having to deal, assumed that God was asleep on the judgment bar of heaven. Since Christ had not returned yet, they concluded that he was not returning and judgment could be averted (2 Pet. 3:3-4). Peter, however, declared: "Their condemnation has long been hanging over them, and their destruction has not been sleeping" (2 Pet. 2:3). Only to the foolish person who thinks God must work according to our timetable and agenda does it appear that the judge is sleeping (2 Pet. 3:8). God keeps his appointments. He fulfills his promises, and he will fulfill the promise that Jesus will return and that there will be a general judgment of all mankind. Any further delay in the final judgment is a sign, not of the sleepiness of God, but of the mercy of God: "He is patient with you, not wanting anyone to perish, but everyone to come to repentance" (2 Pet. 3:9).

I AM A DEBTOR

"I am a debtor both to Greeks and to barbarians, both to the wise and to the foolish hence my eagerness to proclaim the gospel to you also who are in Rome" (Rom. 1:14-15).

What would you think of a person who was deeply in debt to someone else and all the time this person had the ability to pay off the debt but did not? What if the person to whom the money was owed was naive, poor, and ignorant, so that the debtor could avoid paying off the debt? What if the poor, naive person ended up going bankrupt as a result? What would your opinion be of the debtor? You would be outraged at the lack of moral integrity, would you not?

During the Civil Wars in England a man on the Isle of Man was accused of treason and sentenced to death. The king eventually granted a pardon. The pardon fell into the hands of a bitter enemy of the condemned man, and it was never delivered. The man from the Isle of Man was executed. What do you think of someone who possesses a pardon which could save another person's life, but he fails to deliver it, whether intentionally or by neglect? Again, would you not be outraged at the insensitivity and inhumanity of this person?

Paul said that he was a debtor to the people of the world. Of course, Paul was in debt to God for his marvelous grace. Paul was in debt to Jesus Christ for his substitutionary sacrifice of atonement at Calvary. Why should Paul feel a debt to the sinners of the world, most of whom he had never met, many of whom were his enemies? Paul felt the obligation, because God had called him to be an apostle. Paul was "set apart for the gospel of God" (Rom. 1:1). Paul possessed the payment to save others from spiritual bankruptcy. He possessed the pardon from the king to save them from being executed. He had the gospel, the good news of Jesus, which was "the power of God for salvation to everyone who has faith" (Rom. 1:16).
